Introduction

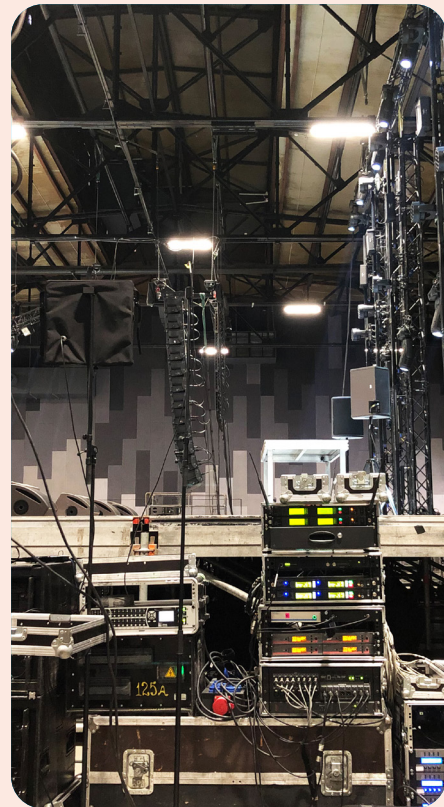
This apprenticeship is for people who want to specialise in a particular area within the entertainment and event technology industry.

People in these roles are experts in their field, and work together to bring performances to life. Working behind the scenes, they are energetic, creative and switched on.

This qualification will be delivered and assessed on-the-job, in a workplace within the performing arts industry.

Graduates of this qualification will be able to safely and independently work in the entertainment and event technology industry using their specialist skills and knowledge.

This qualification is available online and in print.



How long will it take?

This qualification takes 18-24 months to complete.



Core modules

The **New Zealand Certificate in Entertainment and Event Technology (Level 4)** qualification has two core modules:

Health and safety (19 credits)

Working in a production team (31 credits)

The core modules are comprised of unit standards that focus on:

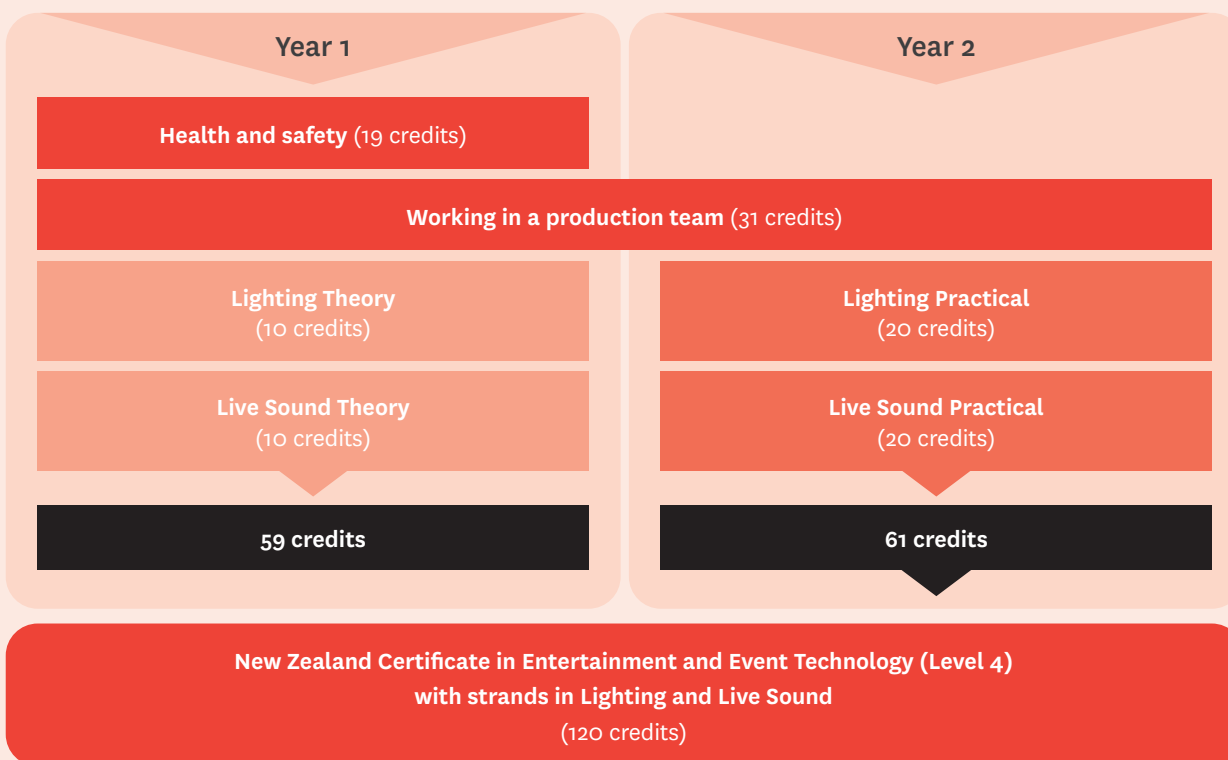
- implementing industry practices, processes and protocols to work effectively as part of a crew and with other departments to meet performance or event requirements
- maintaining professional conduct and etiquette and apply appropriate communication to respond to internal and external stakeholders
- implementing safe working procedures and practices for performance and events
- applying understanding of the entertainment technology industry to develop own career.

Strands

You can choose two strands, or pathways, to complete your qualification. Each strand combines a theory and a practical module.

	Completing the strand means you will be able to...
Lighting	safely install, operate and remove lighting equipment to meet the production and lighting plan requirements for a range of complex performances and events.
Entertainment rigging	safely install, operate and remove rigging equipment to meet the production and rigging plan requirements for a range of complex performances and events.
Live sound	safely install, operate and remove sound equipment to meet the production and sound plan requirements for a range of complex performances and events or a live recording.
Video	safely install, operate and remove video equipment to meet the production and video plan requirements for a range of complex performances and events.
Stage management	implement stage management documentation and production process requirements to ensure the smooth running of a range of complex performances and events.
Stage mechanics	safely set up, operate and remove scenery and stage mechanical devices to meet the production requirements for a range of complex performances and events.
Scenic construction	construct stage scenery using a range of construction methods, equipment and digital technologies for a range of complex performances and events.

What are the costs?

On-job training costs workplaces both time and resources. It can mean covering registration fees, learning and assessment resources, allocating time for training, and having an appropriate assessment pathway available.

Total costs for trainees will vary depending on how the qualification is delivered, how it's assessed and how much support the workplace can provide.

Skills Active apprenticeships are **zero-fees until the end of 2022**, under the government's Targeted Training Fund.
